# About the Trust

The Shrewsbury and Telford Hospital NHS Trust (SaTH) is the main provider of acute hospital services for around half a million people in Shropshire, Telford & Wrekin and mid Wales.

Encompassing some of the most picturesque parts of England and Wales, the Trust's catchment stretches from the Cambrian Mountains in the west, to Newport and the fringes of the Black Country in the east. The main towns include: Bridgnorth, Ludlow, Market Drayton, Oswestry, Shrewsbury and Whitchurch (in Shropshire); Newport, Telford and Wellington (in Telford & Wrekin);and Newtown and Welshpool (in Powys) – all beautiful and unique.

Our main service locations are the Princess Royal Hospital (PRH) in Telford and the Royal Shrewsbury Hospital (RSH) in Shrewsbury which are located 20 minutes' drive apart. Together they provide 99% of our activity. Both hospitals provide a wide range of acute hospital services including accident & emergency, outpatients, diagnostics, inpatient medical care and critical care.

We also provide services such as consultant-led outreach clinics at the Wrekin Community Clinic, Telford, the Robert Jones and Agnes Hunt Orthopaedic Hospital, Gobowen and the Bridgnorth, Ludlow and Whitchurch Community Hospitals.

We employ almost 6,000 staff, and hundreds of staff and students from other organisations also work in our hospitals. We benefit from around 1,000 wonderful volunteers, and our main charitable partners are the League of Friends at the Royal Shrewsbury Hospital, Friends of the Princess Royal Hospital, and the Lingen DaviesCancer Appeal which is based at the Royal Shrewsbury Hospital.

We are committed to providing the best possible diagnostic facilities and high-quality clinical care in a clean, supportive environment where patients are treated effectively with respect and dignity.

The Shrewsbury and Telford Hospital NHS Trust continues to work with our partners in health and social care in Shropshire, Telford and Wrekin and mid Wales to develop patient-focused services that meet the needs of our communities.

Plans have been given the go ahead to transform local hospital services for the half a million residents of Shropshire, Telford & Wrekin and mid Wales to make sure two vibrant hospitals and the wide range of services they provide for people locally are kept in the county. This landmark decision will result in better care for patients, secure the £312m on offer from HM Treasury and develop both hospital sites to deliver state of

#### Job Summary

The successful candidate will be expected to integrate into the working of the respiratory department but also to develop their own interests. We are looking to attract an enthusiastic candidate with a wide experience of respiratory and general medicine. The job plan is illustrative of current working and the respiratory department would be happy to work with the successful candidate to finalise a job plan that meets the needs of the Trust and satisfies the interests and skillset of the candidate. We are particularly keen to employ a candidate with experience in lung cancer and skills in bronchoscopy/endobronchial ultrasound or pleural procedures to enhance our existing rota. Currently, the post holder will be expected to do most of their clinical work at the Princess Royal Hospital site. There is an expectation of cross-site working in the future after our Hospitals Transformation Project is completed. Contribution to an out of hours on call rota is core to this role.

# The Post

#### The Department

The Respiratory Medicine Department currently has a stable workforce of 12 ½ permanent WTE consultants with 6 ½ at the Royal Shrewsbury Hospital and 6 at the Princess Royal Hospital. All but one (0.5 WTE) of the Respiratory Consultants are involved with some aspect of the acute take, and all see general and respiratory outpatients including some delivering peripheral or community clinics within the catchment. We have strong links and support from our excellent Radiologists and both major hospital sites have CT and MRI facilities. Access to PET scanning at Stoke and Wrexham is rapid and streamlined. Weekly x-ray meetings allow for good discussion of complex and interesting cases.

Outpatient new referrals approximate 3,000 to 3,500 per annum shared between colleagues at both hospitals. Respiratory inpatients approximate between 28 and 40 patients at each site at any given time. Each Hospital has a dedicated respiratory ward with Consultants rotating onto wards and attending outliers on allied wards or providing clinical opinions for inpatient respiratory referrals (10 to 20 per week at each site).

Acute Non-Invasive Ventilation (NIV), High-flow nasal Oxygen/Airvo, CPAP and pleural ultrasound are available on the Respiratory wards and there is a Respiratory Specialist Unit at the Shrewsbury site. There are Specialist Nurses in general respiratory medicine, tuberculosis (TB), lung cancer and cystic fibrosis. There is a communitybased supported discharge scheme for COPD patients within in-reach at both sites. There are clinical pathways for prescribing nebulised and intravenous antibiotics for bronchiectasis and access to pulmonary rehabilitation in several venues across the County. A bridging service to chronic NIV is currently available with plans to introduce a chronic NIV service in-house.

Fibreoptic bronchoscopy, Endobronchial Ultrasound (EBUS), lung function tests and domiciliary Sleep Services are available on both sites. A pleural list is currently performed on the Telford site by Consultants from both sites with plans to extend the provision to Shrewsbury. The Indwelling Pleural Catheter service for malignant pleural effusions is due to start in November 2024, and the medical thoracoscopy service (also based at the Telford site with input of Consultants from both sites) is due to start in Spring 2025.

Lung cancer is supported by dedicated oncologists based at Royal Shrewsbury Hospital and by Cardiothoracic Surgeons operating at the Royal Stoke University Hospital but who attend clinics and Multi-Disciplinary Team (MDT) Meetings alternating between Shropshire hospital sites on a weekly basis. We have close links with network neighbours and with the Severn Hospice who have beds close to both Hospital sites.

Interstitial Lung Disease is supported by a monthly regional virtual meeting led by the ILD team at Royal Stoke University Hospital. Adult Cystic Fibrosis services have developed in liaison with Royal Stoke University Hospital. There is a local TB MDT three times a year and the Trust also participates in the bi-annual TB Cohort review with our regional partners from Stoke and Burton. Ambulatory models are in place for management of lower limb deep venous thrombosis and pulmonary embolic disease developed in partnership with our community colleagues and Same Day Emergency Care (SDEC).

#### **General Medicine**

The general medical take is run through the Medical Admissions Units (AMU) at both hospitals and delivered with a split-weekday take by Acute Physicians and Speciality Physicians on the one-call rota. The present oncall is 1/14 with prospective cover. The Trust admits approximately 25,000 acute medical presentations distributed between both hospitals. The Acute Physician teams are responsible for admissions, the AMA and Same Day Emergency Care (SDEC)/ambulatory care between 9am and 5pm (Monday to Friday). On-call Physicians (Acute and/or Speciality) maintain an on-site presence until at least 8pm with on-call thereafter and extended on-site working at weekends (with a subsequent lieu day (TOIL) allotted). Gastroenterologists and Cardiologists operate separate speciality out of hour rotas. Nephrology provide a 24-hour telephone advice service.

The Trust operates a speciality ward system and patients requiring continuing care are allocated to wards from the AMU depending on their presentation.

#### Job Plan

A formal job plan will be agreed between the successful candidate and their Clinical Director and consultant colleagues on behalf of the Medical Director within 3 months of starting in post. A full-time job plan is based on a 10 PA working week. The job plan will be reviewed annually and is a prospective agreement that sets out the Consultant's duties, responsibilities, and objectives for the coming year. It covers all aspects of a Consultant's professional practice including clinical work, teaching, research, education and managerial responsibilities. It will provide a clear schedule of commitments, both internal and external and will include personal objectives, detailing links to wider service improvements and trust strategic priorities.

For a full-time contract, the job plan will be divided on average per week (pro-rata for a part time post) as:

• 7.5 Programmed Activities (PAs) of Direct Clinical Care – includes clinical activity, clinically related activity and predictable and unpredictable emergency work.

• 2.5 Supporting Professional Activities (SPAs) - includes CPD, audit, teaching and research.

The allocation of PAs can be increased by agreement with the applicant and the department. All job plans are reviewed annually and may be subject to adjustment when a further diary exercise is undertaken or if the service demands a review of the team job plan.

Any applicant who is unable, for personal reasons, to work full-time will be eligible to be considered for the post. If such a person is appointed, modification of the job content will be discussed on a personal basis with the Trust in consultation with other consultant colleagues.

If additional hours are worked, consideration will be given to time of in lieu (TOIL) in place of additional payments if requested.

This timetable is indicative only and the formal job plan will be agreed between the successful applicant and their clinical director within 3 months of starting in post.

Clinics typically consist of 3 new patient appointments (30 minutes each), 8 follow up appointments (15 minutes each) with 30 minutes allowed for clinic-related administration.

#### GIM on-call and cover arrangements

The on-call commitment will comprise a full slot with a frequency of 1 in 14. The on-call will be undertaken at the Princess Royal Hospital and includes weekday evenings and weekend work. The general medicine out-of-hours work currently attracts an on-call availability supplement of 3% and 1.5 PAs Direct Clinical Care (DCC). The number of patients admitted in 24 hours varies, but on average a post take ward round will be between 8 and 15 patients and will consist of those still in the Emergency Department. Patients on speciality wards and AMU are reviewed by the ward team that day. Hence morning commitments such as clinic are cancelled to allow for the post take ward round.

#### **Annual Leave**

Doctors upon first appointment to the Consultant grade shall be entitled to annual leave at the rate of 32 days a year.

Doctors who have completed a minimum of 7 years' service as a Consultant shall be entitled to annual leave at the rate of 34 days per year.

The rate of annual leave will be based on a full time contract of 10 PAs. Additional PAs above 10 PAs will not accrue additional entitlements to annual leave over and above the full time allocation. For consultants working part-time, the full time entitlement will be pro-rated in accordance with the contracted PAs.

#### Study and Professional Leave

Professional and Study leave includes but is not restricted to participation in:

- Study, usually but not exclusively or necessarily on a course or programme;
- Research
- Teaching
- Examining or taking examinations
- Visiting clinics and attending professional conferences
- Training

The appointee will be entitled to 30 days of Study/Professional Leave across a 3 year fixed period with a set budget.

#### Research

It is usual for the Trust to be participating in many research projects at any time. Every effort would be made to accommodate a particular research interest you may have, particularly if trainee members of the department could be incorporated in the methodological and practical stages.

#### Audit

Great importance is placed upon audit within the Shrewsbury and Telford Hospital NHS Trust adyou will be expected to contribute to this as part of your role. The Trust has a fully staffed Audit Department at both hospitals with extremely well-organised teams.

#### Appraisal, Revalidation and Mentorship

- The Trust has the required arrangements in place, to ensure that all doctors have an annual appraisal with a trained appraiser and supports all Doctors going through the revalidation process.
- The Trust supports the Royal College of Physicians Guidance on provision of mentors for new Consultants, in line with GMC recommendations. This will be provided within the Trust.
- We will require you to register SaTH as your designated body via the GMC to ensure that you are set up on the Premier IT Revalidation e-Portfolio (PReP) Revalidation System. We will complete this as soon as possible upon your commencement with the Trust.
- The Trust also supports the requirements for continuing professional development and is committed to providing time and financial support for these activities.
- A formal review of the job plan will be performed at least annually. Appropriate educational and training needs will be supported by the Trust, as agreed with the LNC (for example, the approval and funding of study leave).

- An annual job plan review at individual and departmental level is being introduced. You will be expected to participate in this exercise.
- We will require you to register SaTH as your designated body via the GMC to ensure that you are set up on the Equiniti Revalidation System. We will complete this as soon as possible upon your commencement with the Trust.
- The Trust also supports the requirements for continuing professional development and is committed to providing time and financial support for these activities.

#### Accommodation

The Trust offers single residential accommodation for medical staff depending on availability. The Trust only provides single accommodation so private rental would need to be arranged for family accommodation.

#### **Other Facilities**

There is an active Doctors Mess run by the Junior Doctors Mess Committee which organise social events, parties, outings etc. There are on-site fitness centres (a membership fee is payable) available to all members of staff.

#### Office and Secretarial Support

The post holder will have full-time secretarial support with an adequately equipped office that will include a computer with access to Trust IT facilities.

#### Staff Benefits

There are a number of staff benefits schemes which attract tax reductions if joined. This includes a discount on the staff car parking charge, staff gym membership, on-site crèche/childcare provision and access to NHS Discounts schemes.

#### Health & Safety

As an employee of the Trust you have a responsibility to:

- Take reasonable care of your own health and safety and that of any other person who may be affected by your acts or omissions at work, and ensuring a COVID secure workplace for the team.
- Co-operate with the Trust in ensuring that Statutory Regulations, Codes of Practice, Local Policies and Departmental Health and Safety Rules are adhered to.

Whilst you are employed by the Trust you will come into contact with confidential information and data relating to the work of the Trust, its patients or employees. You are bound by your conditions of service to respect the confidentiality of any information you may come into contact with which identifies patients, employees or other Trust personnel, or business information of the Trust. You also have a duty to ensure that all confidential information is held securely at all times, both on and off site.
- Disclosure of Information The unauthorised use or disclosure of information relating to the Trust's activities or affairs, the treatment of patients or the personal details of an employee, will normally be considered a serious disciplinary offence which could result in dismissal. Upon leaving the Trust's employment and at any time thereafter you must not take advantage of or disclose confidential information that you learnt in the course of your employment. Unauthorised disclosure of any of this information may be deemed as a criminal offence. If you are found to have permitted the unauthorised disclosure of any such information, you and the Trust may face legal action.
- Information Quality and Records Management You must ensure that all information handled by you is accurate and kept up-to-date and you must comply with the Trust's recording, monitoring, validation and improvement schemes and processes.

#### Professional Standards and Performance Review

As an employee of the Trust you have a responsibility to:

You will be supported by an Improvement Hub, which will provide the necessary expertise to support you make improvements, while also providing training at various stages of your time at SaTH, as part of your continuing professional development.
