#### About the Trust & Hospital Transformation Programme

The Shrewsbury and Telford Hospital NHS Trust (SaTH) is the main provider of acute hospital services for around half a million people in Shropshire, Telford & Wrekin and mid Wales.

Encompassing some of the most picturesque parts of England and Wales, the Trust's catchment stretches from the Cambrian Mountains in the west, to Newport and the fringes of the Black Country in the east. The main towns include: Bridgnorth, Ludlow, Market Drayton, Oswestry, Shrewsbury and Whitchurch (in Shropshire); Newport, Telford and Wellington (in Telford & Wrekin); and Newtown and Welshpool (in Powys) — all beautiful and unique.

Our main service locations are the Princess Royal Hospital (PRH) in Telford and the Royal Shrewsbury Hospital (RSH) in Shrewsbury which are located 20 minutes' drive apart. Together they provide 99% of our activity. Both hospitals provide a wide range of acute hospital services including accident & emergency, outpatients, diagnostics, inpatient medical care and critical care.

We also provide services such as consultant-led outreach clinics at the Wrekin Community Clinic, Telford, the Robert Jones and Agnes Hunt Orthopaedic Hospital, Gobowen and the Bridgnorth, Ludlow and Whitchurch Community Hospitals.

We employ over 7000 staff, and hundreds of staff and students from other organisations also work in our hospitals. At The Shrewsbury and Telford Hospital NHS Trust (SaTH), there are around 300 volunteers who support patients, their families and colleagues. That net is cast even wider if you include the many charities and organisations whose volunteers also support the Trust including the Lingen Davies Cancer Appeal which is based at the Royal Shrewsbury Hospital.

Our priority is to deliver the best possible diagnostic facilities and high-quality clinical care in a clean, supportive setting. We are committed to ensuring every patient receives effective treatment with respect and dignity.

As part of our long-term vision, to enhance patient care and service delivery, selected services will be either relocating or moving to a cross-site model in 2028. The changes will further bring together our specialist services into a purpose built, modern environment designed to enhance patient care and provide improved working experience for our teams.

As we are currently actively recruiting to roles across services that will be relocating or changing the way the service is delivered, we want to be transparent with all applicants and advise that successful candidates will be expected to move with the service to the Royal Shrewsbury Hospital when the relocation takes place, in early 2028, or move to a cross-site working model.

The relocation will be managed through a formal management of change process, with full consultation and support provided to colleagues throughout the process. An overview of the services that are moving are included on page five of the job pack.

#### **Job Summary**

The Trust is seeking to appoint 1 Consultant Neonatal Paediatrician or Neonatologist. The post is to replace an existing gap in the consultant team. The expansion will enable our team to undertake consultant led transitional care ward rounds, enhance neonatal liaison with paediatric service, improve quality and education within our department and fully embed RCPCH 7 day consultant working at weekends safely. The

full consultant team will consist of 8 Neonatologists/ Neonatal Paediatricians.

The posts attract 10 Pas, part time applicants and job share applications will be welcomed. Additional interests in echocardiography, neonatal neurology, neonatal respiratory medicine or education would be particularly welcome. Contribution to an out of hours on call rota is core to this role.

#### The Post

This is a fantastic opportunity to be part of our warm, and welcoming neonatal team. Our vision is to be one of the top performing LNU in the country: providing the highest quality care for our patients and their families in an environment in which all staff, and in particular trainees, are supported and thrive, with greater delivery of care by consultants in line with RCPCH recommendations.

In October 2014, the obstetric and children's services were re-housed in a modern high specification Shropshire Women's & Children's Centre at Princess Royal Hospital, Telford. The Trust is currently preparing for a £312 million trust wide reconfiguration of services between the 2 hospitals (Royal Shrewsbury Hospital and Princess Royal Hospital) in Shropshire. Emergency Services will be concentrated at the Royal Shrewsbury Hospital, with a Planned Care Centre at the Princess Royal Hospital, Telford (the Hospital Transformation Programme). The Women's & Children's services - including the neonatal service will be at the Emergency Centre.

The Hospital Transformation will be completed in 2028. We welcome dynamic and enthusiastic colleagues to join us on this exciting clinical transformation.

You will work in one of the largest acute District General Hospital Paediatric departments and neonatal units in the Country serving a catchment population of over 0.5 million. The neonatal unit has  $\sim$  4500 deliveries a year and is designated a Local Neonatal Unit (LNU) in the West Midlands Neonatal Operational Delivery network.

The neonatal unit has a full complement of AHPs, according to BAPM specification, as well as a dynamic and progressive ANNP team who work on tier 1 and 2 rotas, undertake a variety of quality and lead roles and undertake NICU clinical attachments within the network. The consultant team undertake regular NICU weeks with the network.

The Paediatric service provides not only a single large Paediatric ward for the County – 36 beds, with specialist high-dependency and oncology areas, but also a large Children's Assessment/Short-Stay 8-bedded unit at the Princess Royal Hospital and a Paediatric Medical Day Case Unit at the Royal Shrewsbury Hospital.

Paediatric specialty services are already well developed in the Trust with the majority of subspecialties having 2 lead consultants. There are separate on-call rotas for acute paediatrics and neonatology at consultant, tier 2 and tier 1 levels.

The Shrewsbury and Telford Hospital NHS Trust is the main provider of district general hospital services for nearly half a million people in Shropshire, Telford & Wrekin and mid Wales.

#### **Our Service**

All Paediatric and Neonatal Inpatient services are currently delivered from the Princess Royal Hospital in a modern purpose-built state-of-the-art Women and Children's Centre. The facilities include:

- A high specification, modern Neonatal Unit, designated as a Local Neonatal Unit. This is Co-located with the Labour Suite, Maternity Operating Theatres and Obstetric Wards.
- A 36 bed children's ward
- Dedicated Oncology and High-Dependency Care 3-bedded Units within the ward
- Independently staffed 8-bedded Children's Assessment Unit at the Princess Royal Hospital 24/7
- Paediatric Medical Day Case facilities at the Royal Shrewsbury Hospital
- New Children's Outpatient Centres at both Hospitals

#### The Neonatal Department

The Neonatal service serves the ½ million catchment population, with over 4500 deliveries per annum. The service is designated as a Local Neonatal Unit (LNU). Our LNUs is supported by regional Neonatal Intensive Care Units (or Level 3 units), mainly the Royal Stoke Hospital NHS Trust. The unit consistently excels for quality of neonatal care in the NNAP audit.

Our unit is staffed and equipped to provide Conventional and synchronised ventilation, Volume targeted ventilation, and short-term High frequency oscillation, as well as active therapeutic hypothermia pending transfer to a NICU. Cranial sonography and echocardiography services are provided locally along with Retinopathy screening. The Unit provides care for babies born at 27 weeks gestation and above and weighing more than 800 grams.

The Neonatal Unit is a modern-day high-specification facility. Located on the first floor, it is immediately adjacent to the Labour Suite and Maternity Theatres and Obstetric Wards, with the Postnatal Ward including Transitional Care, Children's Ward, Assessment Unit and Outpatients facility immediately below on the ground level. There is a Seminar/Education facility within the Neonatal Unit, and a comprehensive Education and Simulation Suite immediately below on the ground floor. There are 3 Intensive Care, 3 High Dependency and 16 Special Care cots. In 2023, the Unit delivered approximately 340 intensive care days, 1061 high dependency days, 3,400 special care and 1,100 transitional care days

The neonatal consultants are separate from the acute paediatric consultant rota. The neonatal consultant team operate a weekly Consultant of the Week system (resident 08:30-17:30 Monday to Friday). With the expansion of the 8<sup>th</sup> consultant post, the neonatal consultant team will provide a combination of resident and non resident on calls) to meet RCPCH 7 day service standards. The resident aspect of the on-calls are: 1700-1930 on weekdays and 1000-1600 at weekends. During non resident on call, consultants are required to return to hospital for emergencies and new ITU/HDU admissions.

The weekends will be split to facilitate safe consultant working and rest according to BMA recommendations. This new model of consultant working will enable consultants to review new admissions and babies receiving intensive and high dependency care according to facing the future standards. All 8 neonatal consultants will spend 2 weeks per annum at a local NICU to keep their neonatal practice up to date.

There are entirely separate tier 1, and tier 2 neonatal rotas at all times consisting of foundations doctors, post graduate doctors in training, specialist doctors, Advanced neonatal nurse practitioners and a simulation based education fellow.

There is an active 7-day Neonatal Outreach Service provided by senior neonatal nurses. The team looks after babies discharged home on oxygen, early discharge of babies on home tube feeding, those with discharge weight<1.8 kg, those with neonatal abstinence syndrome on medications and other specific needs. There are plans underway for virtual ward and home phototherapy.

The Obstetric Service consists of the Consultant-led Labour Suite (approximately 3900 deliveries per annum), with approximately lower-risk 800 deliveries at the Midwife-led Delivery Unit in Telford. The Obstetric service has 17 Consultants including 2 Subspecialists in Maternal and Fetal medicine with a very active and integrated prenatal diagnostic practice supported by midwifery sonographers.

#### The Children's Ward

The Children's Ward has 36 beds, with 20 accommodated in 2- or 4-bedded bays, and 16 in cubicles, each with en-suite accommodation. The ward has a dedicated 3-bed Oncology Unit with its own parent accommodation, Treatment Rooms and office accommodation, and delivers the highest quality of care as a Level 3 Paediatric Oncology Shared Care Unit. 3 beds are dedicated, and staffed, for High-Dependency Care delivering CPAP and High-Flow Oxygen facilities. The Ward's resuscitation room allows for initiation of PICU support, including ventilation, and there are well-established links with the Region's PICU centres at Stoke and Birmingham and with the immensely supportive and efficient Regional Transport and PICU advice service

(KIDS) based at the Birmingham Children's Hospital.

There are currently in excess of 6,000 admissions per annum to the Children's Ward, with a further 8000+ attendances at the Children's Assessment Units.

#### The PRH Children's Assessment Unit

Separately staffed and open 24/7, this facility has 8 beds, with 4 as en-suite cubicles, and a separate Treatment Room for practical procedures. Length of stay is already little over 24 hours for children in Shropshire, and the CAU help further facilitate earlier discharge home and ward admission avoidance.

#### The RSH Paediatric Medical Day Case Unit

Reconfiguration has ensured that cost effective services are provided with an emphasis of quality of care and effective triage of patients. The Paediatric Medical Day Unit at the Royal Shrewsbury Hospital is a 6-bedded unit. Opening hours reflect the need to deliver care for peak attendance hours, 09:00-17:00hrs Mon-Fri. The unit is staffed by highly experienced Advanced Paediatric Nurse Practitioners or Associate Specialists. Comprehensive care pathways have been developed to manage the admission of ill or injured children, whether they present to the Royal Shrewsbury Hospital or Princess Royal Hospital. The Paediatric team at RSH plays an important role in supporting the A&E Department at the Royal Shrewsbury Hospital, which is also the designated Trauma Unit for the County. This support is available from 9am to 7 pm 5 days/week and between 12pm and 10pm on a Saturday and Sunday.

#### Children's Outpatients

At both the Royal Shrewsbury Hospital and Princess Royal Hospital, there are new, enhanced out-patient facilities. Each also contain its own treatment room, clean and dirty utility and administration areas, allowing greater delivery of care away from the in-patient unit.

Children's general paediatric out-patient clinics are also delivered in the excellent facilities provided by a number of the local Community Hospitals (in Whitchurch, Ludlow, Bridgnorth, Welshpool and Newtown) and in the specialist Robert Jones and Agnes Hunt Orthopaedic Hospital, Oswestry.

There is comprehensive provision of specialist services in the out-patients, including:

A. Visiting Tertiary Specialists: Cardiology, Nephrology, Urology, Surgery, Endocrinology, Cystic Fibrosis, Oncology & Haematology, and Genetics.

B. In-County Specialist Clinics: Gastroenterology, UTI/Renal, Cardiology, Allergy, Respiratory, Cystic Fibrosis, Rheumatology, Diabetes, Endocrinology, Oncology & Haematology, Metabolic, Epilepsy and Neurology

#### Job Plan

A formal job plan will be agreed between the successful candidate and their Clinical Directors and consultant colleagues, on behalf of the Medical Director within 1 month of starting in post. A full-time job plan is based on a 10 PA working week. It covers all aspects of a consultant's professional practice including clinical work, teaching, research, education and managerial responsibilities. It will provide a clear schedule of commitments, both internal and external and will include personal objectives, detailing links to wider service improvements and trust strategic priorities.

For a full-time contract, the job plan will be divided on average per week (pro-rata for a part time post) as:

- 7.5 Programmed Activities (PAs) of Direct Clinical Care includes clinical activity, clinically related activity and predictable and unpredictable emergency work.
- 2.5 Supporting Professional Activities (SPAs) includes CPD, audit, teaching and research.

The allocation of PAs is reviewed annually and may be subject to adjustment when a further diary exercise is undertaken or if the service demands a review of the team job plan.

Any applicant who is unable, for personal reasons, to work full-time will be eligible to be considered for the post. If such a person is appointed, modification of the job content will be discussed on a personal basis with the Trust in consultation with other consultant colleagues.

This timetable is indicative only and the formal job plan will be agreed between the successful applicant and their clinical director within 1 month of starting in post.

#### On-call and cover arrangements

• Neonatal consultants cover a 1 in 8 weekday on call and 1 in 4 weekend on call (either Saturday or Sunday), covering only the neonatal unit.

## **General Conditions**

#### **Annual Leave**

Doctors upon first appointment to the Consultant grade shall be entitled to annual leave at the rate of 32 days a year.

Doctors who have completed a minimum of 7 years' service as a Consultant shall be entitled to annual leave at the rate of 34 days per year.

The rate of annual leave will be based on a full time contract of 10 PAs. Additional PAs above 10 PAs will not accrue additional entitlements to annual leave over and above the full time allocation. For consultants working part-time, the full time entitlement will be pro-rated in accordance with the contracted PAs.

#### **Study Leave**

Professional and Study leave includes but is not restricted to participation in:

- Study, usually but not exclusively or necessarily on a course or programme;
- Research
- Teaching

- Examining or taking examinations
- Visiting clinics and attending professional conferences
- Training

The appointee will be entitled to 30 days of Study/Professional Leave across a 3 year fixed period with a set budget.

#### Research

It is usual for the Trust to be participating in many research projects at any time. Every effort would be made to accommodate a particular research interest you may have, particularly if trainee members of the department could be incorporated in the methodological and practical stages.

#### Audit

Great importance is placed upon audit within the Shrewsbury and Telford Hospital NHS Trust adyou will be expected to contribute to this as part of your role. The Trust has a fully staffed Audit Department at both hospitals with extremely well-organised teams.

#### Appraisal, Revalidation and Mentorship

- The Trust has the required arrangements in place, to ensure that all Doctors have an annual appraisal with a trained appraiser and supports all Doctors going through the revalidation process.
- The Trust supports the Royal College of Physicians Guidance on provision of mentors for new Consultants, in line with GMC recommendations. This will be provided within the Trust.
- We will require you to register SaTH as your designated body via the GMC to ensure that you are set up on the Premier IT Revalidation e-Portfolio (PReP) Revalidation System. We will complete this as soon as possible upon your commencement with the Trust.
- The Trust also supports the requirements for continuing professional development and is committed to providing time and financial support for these activities.
- A formal review of the job plan will be performed at least annually. Appropriate educational and training needs will be supported by the Trust, as agreed with the LNC (for example, the approval and funding of study leave). An annual job plan review at individual and departmental level is being introduced. You will be expected to participate in this exercise.
- We will require you to register SaTH as your designated body via the GMC to ensure that you are set up on the Equiniti Revalidation System. We will complete this as soon as possible upon your commencement with the Trust.
- The Trust also supports the requirements for continuing professional development and is committed to providing time and financial support for these activities.

#### Accommodation

The Trust offers single residential accommodation for medical staff depending on availability. The Trust only provides single accommodation so private rental would need to be arranged for family accommodation.

#### Other Facilities

There is an active Doctors Mess run by the Junior Doctors Mess Committee which organise social events, parties, outings etc. There are on-site fitness centres (a membership fee is payable) available to all members of staff.

#### Office and Secretarial Support

The post holder will have full-time secretarial support with an adequately equipped office that will include a computer with access to Trust IT facilities.

#### **Staff Benefits**

There are a number of staff benefits schemes which attract tax reductions if joined. This includes a discount on the staff car parking charge, staff gym membership, on-site crèche/childcare provision and access to NHS Discounts schemes.

#### Health & Safety

As an employee of the Trust you have a responsibility to:

#### Infection Prevention and Control

The prevention and management of acquired infection is a key priority for the Trust. Any breach of Infection Control Policies is a serious matter which may result in disciplinary action. As an employee of the Trust you have a responsibility to:

- Ensure that your work methods are compliant with the Trust's agreed policies and procedures and do not endanger other people or yourself.
- Be aware of Infection Prevention and Control Policies, Practices and Guidelines appropriate for your duties and you must follow these at all times to maintain a safe environment for patients, visitors and staff.
- Maintain an up-to-date knowledge of Infection Prevention and Control, Policies, Practices and Procedures through attendance at annual mandatory updates and ongoing continuing professional development.
- Challenge poor infection prevention and control practices of others and to report any breaches, using appropriate Trust mechanisms (e.g. incident reporting policy).

#### Information Governance

The Trust is committed to compliance with Information Governance standards to ensure that allinformation is handled legally, securely, efficiently and effectively. You are required to comply with the Trust's Information Governance policies and standards. Failure to do so may result in action being taken in accordance with the Trust's Disciplinary Procedure.

- Confidentiality and Security Your attention is drawn to the confidential nature of information collected within the NHS. Whilst you are employed by the Trust you will come into contact with confidential information and data relating to the work of the Trust, its patients or employees. You are bound by your conditions of service to respect the confidentiality of any information you may come into contact with which identifies patients, employees or other Trust personnel, or business information of the Trust. You also have a duty to ensure that all confidential information is held securely at all times, both on and off site.
- Disclosure of Information The unauthorised use or disclosure of information relating to the Trust's
  activities or affairs, the treatment of patients or the personal details of an employee, will normally be
  considered a serious disciplinary offence which could result in dismissal. Upon leaving the Trust's

employment and at any time thereafter you must not take advantage of or disclose confidential information that you learnt in the course of your employment. Unauthorised disclosure of any of this information may be deemed as a criminal offence. If you are found to have permitted the unauthorised disclosure of any such information, you and the Trust may face legal action.

Information Quality and Records Management - You must ensure that all information handled by you
is accurate and kept up-to-date and you must comply with the Trust's recording, monitoring,
validation and improvement schemes and processes.

#### Professional Standards and Performance Review

As an employee of the Trust you have a responsibility to:

- Participate in statutory and mandatory training as appropriate for the post.
- Maintain consistently high personal and professional standards and act in accordance with the relevant professional code of conduct.
- Take responsibility for the maintenance and improvement of personal and professional competence and to encourage that of colleagues and subordinates.
- Participate in the Trust's appraisal processes including identifying performance standards for the
  post, personal objective setting and the creation of a personal development plan in line with the NHS
  Knowledge and Skills Framework outline for the post.

#### Safeguarding Children and Vulnerable Adults
